






Training centre


Dates were fixed and 2 classrooms given over exclusively to the project.

Solutions

Results from the tests alongside trainer observations and questionnaires asked of the participants have contributed to D5.2 & D5.3





Participants

Participants numbers split between 2 groups – trained and non-trained.

- •May through to August 2021: Trials and testing with 15 trainers and 20 student driving instructors whilst simulator build continued.
- •September and October 2021: 120 public test participants with 4 trainers on-site (4 Simulators set up).
- •November 2021: Completion of any outstanding test phases.



Challenges faced

Challenges were faced and solutions found were possible to the following in completing the study.

Delays in the development of simulator: The simulator with Highway scenario has been completed at the end of July 2021

During the tests, elements of critical situations were requested in the scenarios, but it was not always possible to obtain them due to development difficulties. An example being the highway contraflow.

Problems connecting to the server during HSS tests. Due to the planning of the HSS tests in the UK taking place at weekends, no online support was available initially from LIST during these periods as not a seven-day operation. Connection issues were logged during 2 weekends out of the 4 planned for testing. This resulted in no connection to the LIST servers and 48 HSS participants not being able to participate in the study

Due to the crisis that has spread across Europe, the cities and businesses originally intended for the test have been varied based on travel Pandemic restrictions, indoor social gathering bans and other preventative measures adopted or confirmed by the government and local authorities. The program originally planned for 2020, i.e., before the pandemic, has also undergone a major rescheduling, having to recognise and deal with both travel and simulation times with experienced drivers / students taking longer than originally envisaged.



Efforts were made to reschedule any missed tests where possible, LIST having been pre-notified of any out of hours testing, arranged support during these periods to facilitate 24 participants to revisit on new dates and subsequently participate over 2 additional weekends.







Trainer Workshop & Desktop Study

Joint workshop UK & Italy and also UK only study and workshop into related research.

In addition, and simultaneously to the HSS tests conducted with all types of participants as described, workshops were organized with the partners involved (ACI, RDS and List) to analyse together the results from the different points of view and define a shared training program.

RDS conducted additional trainer workshop and desktop study with a group of ten UK based driving instructor trainers to discuss the challenges posed to driving instruction in a future where CAV's become more prevalent.

Further conclusions from this workshop were included within the deliverable D5.3.
